I verify that my child has been checked by a licensed physician and is physically able to participate in the training offered by Nexus Athletic Club. I hereby agree that I will not hold Nexus Athletic Club, its' director(s), or its' contractors responsible for any loss, damages, or personal injury incurred as a result of participation. I hereby authorize the Directors of the activity to act for my child according to their best judgment in an emergency requiring medical attention. I agree to allow my child to be treated by a licensed physician (if necessary) and I will assume all costs related to such treatment. I authorize my insurance company to pay benefits and I also authorize the disclosure of medical information to my insurance company for the purpose of the claim.

**Athlete/Staff Requirements and the Assumption of the Risk
and Waiver of Liability Relating to Coronavirus/COVID-19**

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to- person contact, including individuals without disease symptoms. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited or limited the congregation of groups of people.

The health and well-being of our staff and athletes remains our top priority. In order to minimize the risk of COVID-19 entering our environment and spreading amongst our community, we will only allow staff assigned to work and athletes scheduled to participate to be in our gym. Parents wishing to remain on site can use outdoor common areas or the parking lot to wait for their athlete(s). Athletes waiting to attend a session will need to wait outside while maintaining social distance from others.

Furthermore, all participants in activities sponsored by Nexus Athletic Club and being held at ASC Avondale must agree to and abide by the following:

- All staff and participants will be using the front entrance (West) as an entrance only and the East exit as an exit only.
- Everyone entering the building will have to stop at our check-in tables and have their temperature taken.

- All staff will be wearing face coverings. *Athletes will not be required to wear face coverings but may do so if they choose.
- Players may not linger after practices are over, they must immediately exit the facility.
- There is a max of 10 players and 2 coaches per court.
- Participants may not enter the facility any more than **10 minutes** before their scheduled practice.
- Parents may escort their players to practice/session but Nexus is asking that you do not remain in the facility to assist in social distancing and keeping facility occupancy as low as possible. Only players and coaches are to be at court at any time.
- We are asking that people bringing water bring in a limit of 1 sealed water bottle. This means no hydroflasks or other reusable containers. We will have water in the vending machines for purchase as well.
- We will be increasing our routine disinfection of the facility as well, and there will be a 15 minute break between practices to allow us to disinfect each court area. No one besides staff should be in the area being disinfected during this time period.
- No outside balls, chairs, equipment, etc. * Coaches may still bring in balls for practice. These balls will be sanitized by ASC Staff before use each day.
- Everyone must maintain the social distance of 6 feet as much as possible while in the facility.

Nexus Athletic Club (hereafter referred to as the “Club”) has put in place numerous preventative measures and enhanced cleaning protocols to reduce the likelihood of spreading COVID-19 in Club’s gym environment; however, the Club cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending sponsored activities at the Club could increase your risk and your child(ren)’s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily agree to the participation terms described above and assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending the Club and that such exposure or infection may result in personal injury, illness, permanent disability, and death.

I understand that the risk of becoming exposed to or infected by COVID-19 at the Club may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Club employees, volunteers, and program participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)’s attendance at the Club or participation in Club programming (“Claims”).

On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless the Club, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto.

I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Club, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Club activity.
